HVLS FANS UNITED STATES & CANADA LIMITED WARRANTY

1.PURPOSE

To define 4FRONT's limited U.S. & Canadian warranty as it applies to HVLS Fan products and their controls.

2.WARRANTY COVERAGE

THIS LIMITED PRODUCT WARRANTY ("Limited Warranty") IS THE SOLE AND EXCLUSIVE WARRANTY MADE BY 4FRONT SOLUTIONS, LLC ("4FRONT") IN CONNECTION WITH THE HVLS FAN ("Product"). OTHER THAN THE LIMITED WARRANTY SET FORTH HEREIN, 4FRONT MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AND IS IN LIEU OF ANY OTHER GUARANTES OR WARRANTIES. THIS LIMITED WARRANTY APPLIES ONLY TO THE ORIGINAL PURCHASER OF THE HVLS FAN AND CANNOT BE TRANSFERRED.

4FRONT expressly warrants to the original purchaser of the Product **("Owner")** for a period of one (1) year from the date that is either:

- 1. Sixty (60) days after the initial date of shipment by 4FRONT to the Product Owner, **OR**
- 2. The date of installation of the Product by the Owner, **whichever occurs first** ("Trigger Date"),

that the product will be reasonably free of defects in materials and workmanship. This Limited Warranty only applies to 4Front's Products, which are used, stored, handled, installed, and operated in the manner set forth in the User Manual ("Warranty Period").

If the Product, as determined solely by 4FRONT, does not perform as warranted solely due to a manufacturing defect within the Warranty Period, subject to the exclusions set forth in this Limited Warranty, and if properly notified by the Owner, 4FRONT will, <u>at its option</u>, either:

- Replace the Product, or the deficient portion(s) thereof, without charge to the owner (to include all parts and labor) ("Replace");
- 2. Alter or repair the Product, on site or elsewhere, without charge to the owner ("Repair"); OR
- 3. Return the Product and refund the purchase price.

Replace or Repair during the Warranty Period includes reasonable labor charges necessary to repair or replace the defective product with the style, model, and/or color of the Product that is available at the time of the repair or replacement and is limited to the repair or replacement of only the specific Product that fails due to a manufacturing defect. Any repaired or replaced Product shall also remain subject to the original Warranty Period from the original Trigger Date as set forth above, and any repair or replacement shall not extend the original Warranty Period in any manner or start a new warranty period.

IN ADDITION TO THIS LIMITED WARRANTY, 4FRONT WARRANTS THE PRODUCT ACCORDING to the table below for parts only:

2.1. HVLS FANS

* Mechanical is defined as the mechanical components of the fan including the powerhead (motor and gearbox), fan hub, mounting, airfoils, and winglets.

** Electrical is defined as all electrical and electronic components of the fan, including the Variable Frequency Drive (VFD) and all components of the VFD panel. This does not include the touchscreen controllers.

All products are considered for indoor use only.

3.DISCLAIMER OF WARRANTIES

4FRONT's Products must be stored, handled, installed, used, and maintained in accordance with instructions provided by 4FRONT, and this Limited Warranty is conditioned upon compliance with all such instructions.

This Limited Warranty does not cover any failure(s) caused by:

- 1. Non-compliance with 4FRONT's User Manual. Such failures include, but are not limited to, exposure to physical abuse, including, but not limited to thermal abuse or shock (e.g., excessive heat or cold) or misuse;
- 2. Improper storage, installation, handling, use and/or of the Product, including but not limited to mounting location and exclusion zone violations, improper operation, negligence, or failure to maintain and adjust the Product properly;
- 3. Damage not resulting from manufacturing defects that occur while the Product is in the customer's possession, including but not limited to Parts requiring replacement due to damage resulting from vehicle impact, abuse, or improper operation;
- 4. Unreasonable or unintended use of Product; or
- 5. Products installed with known or visible manufacturing defects at the time of installation.

This Limited Warranty will be null and void if the Owner fails to notify 4FRONT's warranty department using the procedures set forth herein within ninety (90) days after the Product deficiency is discovered.
